Background

The UK government has guaranteed to fund successful MSCA COFUND 2023 applicants who had indicated a UK host in their proposal.

MSCA grants may not be hosted by entities in countries that are neither Member States nor associated to the Horizon Europe programme. As the UK was not formally associated to this work programme, MSCA COFUND grant agreements cannot be signed if they have a listed organisation from the UK.

The [EC and the UK government have confirmed](#) that the UK will be associating to Horizon Europe from the 2024 work programme and participating as a fully associated member for the remaining life of the programme until 2027.

Grant administration

UK MSCA COFUND awards will be administered and funded by UKRI as part of the Horizon Europe guarantee. No further assessment of the grant will be carried out by UKRI.

Please note that MSCA COFUND grants funded by UKRI will be administered according to UKRI standard research grant terms and conditions except where specifically noted in the additional grant conditions below.

Who is eligible and how to submit your details

Anyone who has confirmation of a successful evaluation for an MSCA COFUND grant which is covered by the guarantee as noted in [the guarantee guidance document on UKRI's website](#) may submit their project details via the UKRI Funding Service to receive funding from UKRI for their project.

UK partners will submit their project details by using the application link above. When the link is clicked it will take the applicant/partner to the online application form in the service.

At this point the applicant will be asked to confirm that they will be leading their project. Once confirmed, the applicant will be taken to a page which asks if they have a Funding Service account?

If you already have a Funding Service account, please login using these details. Applicants can only create an account when you start your first application using the service.

If you don't have an account, you will be asked to create one. To submit your details to UKRI, the host institution must be based at an organisation registered with the UKRI Funding Service.

If your institution does not appear as a registered organisation, please contact support@funding-service.ukri.org who will be able to assist you with the set-up process.

Before you start

Joint proposals:

For this call, each UK-based partner will hold an individual UKRI grant and receive their funds directly. **This requires each partner in the network to submit their own proposal in the UKRI Funding Service.**

Funding will be awarded to each organisation based on the resources entered on each of the UKRI Funding Service applications. Therefore, each grant must include its own currency conversion tool to reflect the funds they require.

NB: Unlike Je-S, the UKRI Funding Service does not require applicants to state specifically if their proposal is part of a wider UK Joint Proposal involving other UK partners.

Implementing Partners:

For UK-based organisations included in a successful COFUND project as an implementing partner, the Horizon Europe guarantee will cover the EU contribution. Implementing partners are clearly listed in Part B Section 5 Partner Organisations of the original proposal. When completing the UKRI conversion tool, please multiply the number of recruited researchers by the corresponding COFUND allowance. The letter of commitment as well as the original proposal and grant agreement should be included in your submission through the UKRI Funding Service. More details on the other required attachments can be found below.

Start Date:

The start date of your guarantee grant does not need to match the start date in the original MSCA COFUND proposal. System constraints will require you to submit a future start date at time of submission. However, when you submit the starting confirmation form for the grant you may enter an actual start date before the date given on the grant offer letter if desired.

Please note that the duration of the grant does need to match what was in your original MSCA proposal.

Exchange rate:

We will not accept any increase of budget from that originally applied for in your MSCA COFUND application. As payments will be paid in British pounds (GBP) rather than Euros all costings will need to be entered into the UKRI Funding Service as GBP. The maximum exchange rate is listed in the [guarantee guidance here](#).

Currency conversion tool:

To convert the costs to GBP using simplified UKRI cost headings, the UKRI conversion tool template must be used and uploaded as a PDF attachment. This can be found on the [Horizon Europe guarantee notice and guidance page](#) under the specific call.

The spreadsheet will automatically calculate the costs in GBP using the correct maximum exchange rate. The second table will display what information needs to be inputted into the Resources and Costs section of the UKRI Funding Services application.

Please ensure you save a copy of your completed conversion tool template as a PDF. This can be done whilst saving the document in Excel by choosing 'PDF (*.pdf)' in the drop-down list instead of 'Excel Workbook (*.xlsx)'.


Attachments:

Please prepare the following required attachments prior to completing the UKRI Funding Service application, noting that no further assessment of the grant will be carried out by UKRI. **These must be saved as PDF files before uploading to the UKRI Funding Service:**

- Evaluation result letter from European Commission stating your success in the 2023 MSCA COFUND call
- Full copy of the original proposal (parts A and B) – This can be downloaded from the submission system. Please note if the size of the proposal is over 8 MB you will need to reduce the size of the document before submitting it through the UKRI Funding Service. UKRI will need a full copy of the original proposal, so do not delete any pages, but you can reduce the size of the PDF on Adobe or it can be submitted in parts as multiple attachments if necessary.
- MSCA evaluation summary report
- Completed UKRI currency conversion tool
- Horizon Europe grant agreement digitally signed by the European Commission

To move through the application process, you will click onto the section headings (Details, Your reference etc). As you complete the sections the overview page will indicate which sections have or have not been completed and also give a percentage of the application completed up to that point on the right-hand side.

On the next page you will find a screenshot of one section from the application. The example section being used here is “Ethical Information: Research involving human participation”, however this guidance will be relevant to the majority of sections.

1. This is the section title.
2. This will either be a question for the applicant to answer or a direction for the applicant to follow.
3. If you click on the underlined text with the arrow to the left it will reveal further guidance via a drop-down as how to complete the question/direction.
4. The drop-down will always explain what is required, even if the section is not relevant for your proposal.
5. Some of the sections will allow/require you to upload a document in PDF format. Again, if you click on the underlined text with the arrow to the left it will reveal further guidance via a drop-down.
6. You will locate your file on your computer here and upload a single PDF ensuring it is no larger than 8MB.
7. Once you are happy that the section is finished you will mark it as complete.
8. Finally, you will save the section and click on the green “save and return” button, at which point you will be taken back to the Application Overview screen.

The following sections have a slightly different format however we have provided further information on how to complete those in the Table 1 (page 7).

Submitting your project

When all sections of your application are complete, please notify your research office so they can do any final checks, edits and approvals before submitting the application.

Research office staff with an administration status Funding Service account view all applications from your organisation (including draft applications) and can edit all sections when the application is sent for approval.

The research office then submits the application to UKRI.

If your organisation does not have a research office, you can submit the application yourself using the Funding Service.

Next steps

UKRI will acknowledge the submission and conduct checks on the documents you have submitted. You can monitor the progress of your application from submission to outcome using your Funding Service account.

Once UKRI has processed the submission, a grant offer letter will be issued containing UKRI terms and conditions relevant to the financial and reporting aspects of the programme of

work within the project. These will include the additional grant conditions, as explained below in Annex 2.

Grant holders will be expected to report research outcomes through [Researchfish](#). Grants will probably fall under the regular programme of assurance checks carried out on Research Council grants; however, we reserve the right to carry out additional monitoring as required.

Annex 1: Resource and costs guidance

We only require one single cost figure to be entered and this is your total requested contribution taken from the cost conversion tool. The figure will be entered into the **Exceptions - other** funding type, rounding up to the nearest pound.

The following guidance will take you through the steps need to add the figure and will be dependent on how many core team members are listed and the institutions which they are based.

- You will complete steps 1 to 5 for all organisations.
- Step 6 will apply to all organisations **except** the Project Lead's host organisation. If there are no staff members listed from organisations other than Project Lead's host organisation, then follow steps 1 to 5 and then 7.
- Step 7 is where you will add the total UKRI contribution from the cost conversion template. This will **only** apply for the Project Lead's host organisation.

In this example the Project Lead (PI) from Abertay University has added a Research Assistant from University of Nottingham and a Technician from Abertay. The project is due £100,000 in funding.

1. The first screen you will be presented with when you enter the resources and costs section of the application overview shown is below. First, click on the organisation (University of Nottingham) hyperlink (1).

Call condition 1: Rate of funding

100% of the EU-eligible costs applied for through the European Research Executive Agency ("REA") on this grant will be paid for in GBP (£), subject to the maximum exchange rate as given in the guidance.

Call condition 2: Exchange rate

UKRI shall be permitted to change the GBP (£) value of the grant where in UKRI's opinion there is a significant fluctuation in the GBP: EUR exchange rate from the exchange rate previously used to calculate the GBP (£) value of the outstanding grant sum provided always that:

- i. the GBP value of the grant shall not change more than once in any 12-month period; and
- ii. the revaluation process shall not affect payments which have already been made to the Recipient.

Call condition 3: Acknowledgment, naming, branding and communications
