ANNEX 1 - The Specification

- 1 The Supplier shall provide the Goods and/or Services in accordance with this Annex 1 and Schedule 2 of the Agreement.
- 2 This requirement is investigation and modifications to the RRS Sir David Attenborough vessel's uncontaminated sea water system to resolve recent system failures due to piping and system equipment failure.

Scope of works

Following the initial desktop study and technical note '00427-150065-12295 Technical Note - SDA UCSW Mod Support R0' it has been found that the requested stainless steel, plastic lined pipework is fabricated at the manufacturer's facility. Due to this, accurate Isometric drawings will need to be provided to them. To give the best opportunity to fit the pipework during the September 2024 docking period the following additional work is required:

3D designer scope (pre-survey)

 Extract data from existing Navisworks 3D model to provide measurements for checking onsite in July. - Set up of model for comparison with 3D scan data

3D Scan (survey)

 On-site checking of measurements from initial modelling (included in CTR 109) - On-Site 3D scan of pipe run from retractable probe to UCSW pump suction

The below scopes shall be completed following a vessel visit in Rosyth in July 2024, - Comparison of 3D scan and existing 3D model:

- Produce Isometric drawings for submission to manufacturer
- Liaison with 3rd party 3D scanning company & pipe manufacturer for supply of Isometrics
